# Monroe County Employees Retirement System Board of Trustees MINUTES

## **Presentations** – Guy Torres, Pacific Income

Michael Cho introduced Guy Torres, Vice President Regional Director, Pacific Income Advisers.

Guy Torres thanked the board for having him and overviewed Pacific Income Advisers with a brief introduction. Pacific Income Advisers is based in Santa Monica, CA and have been since 1986 and have 26 years experience managing taxable bond portfolio for their clients. They are completely independent employee owned and have been independent since they started and have been able to maintain that independence to present day.

Pacific Income has about thirteen billion dollars in assets under management and because their company is a taxable bond manager the majority of their clients are institutions, so they do a lot of Public, County, and City plans, police pensions, etc.

Monroe County Employee Retirement System's portfolio from the beginning of the year, January 1, 2012 through October 31, 2012:

Beginning Market Value of \$ 9,723,432 Contributions of \$ 2,264,341 Net Gain \$ 447,146 Ending Market Value of \$12,434,919

Since inception the Net Gain of this portfolio has been a little over 4.6 million dollars. When compared with a blended benchmark index, the rate of return outperformed by approximately 37 basis points year to date.

Anne McCarthy asked if there were other index/indices that could be used, instead of the one that was used and Mr. Torres replied that the one used was a primary one that is known as the bond indices. In the intermediate range (all of the individual bonds mature within ten years) the index that was used is the most incorporated in all their opinion. Overall, since inception there has been an annualized return of 5.00% per year versus 4.85% for the index.

Portfolio characteristics – average quality of the portfolio is Aa2/AA- with the highest credit quality rating being AAA. Most of the corporate issuance is in A, BBB. Monroe County Employee Retirement System's distribution is about 38% in Treasury, 24% in Agency, approx 14% in A corporate bonds and about 24% in BBB.

Mr. Torres said that this is really a high quality portfolio with about 38% in corporate bonds and 28% for the index.

# **Attorney's Report**

1. Code of Conduct/Education/Travel/Due Diligence Policy – Discussion followed Thomas Michaud's report of the latest draft of the policy. Michael Grodi asked if it would be appropriate to put gratuity language in the meal reimbursement and suggested that it be included to eliminate confusion.

William Sisk said that he would support the motion, but he was not sure that it would be enough.

Anne McCarthy stated that she appreciated all of the work that everyone does on the board and that all of the members have the best interest of the employees and citizens of the County. Anne McCarthy also said that she wanted to make it clear that the board was not bullied or threatened into making the changes to the policy.

Michael Grodi said that this will be the first budget for travel that this board has had and that this will be a work in progress and he hopes that the Board of Commissioners will recognize this as a step.

LaMar Frederick spoke before the board and said that he did not see a sense of urgency by the pension board in the past to establish a travel program, but said that the sense of urgency has now been recognized. Mr. Frederick asked for clarification about the one out of state conference and what it meant.

William Sisk answered and said that with the cap that is indicated in the proposed policy that travel would be kept to within those limits.

Mr. Frederick said that he felt that vacation time should not have to be used to attend functions for the Retirement board if you were an employee. His thought was that each person should have forty hours allowed without having to use vacation time as an employee. Mr. Frederick said that he is willing to support the proposed policy agreement that was presented.

Nancy Bellaire thanked the fellow board members for their support and contribution.

Motion by Joseph Hudson, supported by James Davies to adopt the proposed Policy with the revision to the meal allowance to include the gratuity.

2. Heart Act Amendments – Thomas Michaud discussed the Act Amendments and recommends to the board to adopt the resolution as presented.

## **Consultant's Report**

Michael Cho discussed the quarterly report – overviewed the Federal governments, European governments, Bank of England, Bank of Japan and Bank of China all having monetary easing policies. Michael Cho said that we had a very strong and positive third quarter for the equities and fixed income came in at a moderate rate.

Overall performance for the third quarter was 4.4%, versus the Manager Allocation Index at 3.86% and Policy Index at 3.35%. 2012 YTD – 7.93%, Manager Allocation Index at 7.93% and Policy Index at 8.39%. Since inception – June 1990, performance is 7.99%, Manager Allocation Index at 7.94% and Policy Index at 7.96%. Change in value for the quarter – Beginning Market Value \$168,660,000, Net Flow (-1,190,000), Investment Earnings \$7,136,000 with the Ending Market Value at \$174,605,000.

Asset Allocation currently is 46.3% in Equities, 48.3% in Fixed Income and 5.4% in Cash. Mr. Cho said that this is a conservative allocation.

Mr. Cho overviewed the performance of managers. Anchor Capital, Renaissance International Equity, Eagle Global International, Lazard Emerging Markets all underperformed for the quarter.

Anne McCarthy asked why are we keeping the underperforming managers and wondered if there were other options / managers that we could bring in or substitute for them. She asked Mr. Cho if he could research this and let the board know at the next meeting. Mr. Cho said that he would look into alternatives or combining managers and present at a future meeting.

Mr. Cho reviewed the valuation report for the month ending October 31, 2012. The fund is valued at \$173,984,652.72 down \$620,410.96 from the previous month. The Total Fund was down .29% and up 7.62% YTD. The current asset allocation includes 48.42% in equity, 49.48% in fixed income, and 2.10% in cash.

Mr. Cho postponed the presentation that was scheduled and asked to move it to the January meeting.
