11. Consultant's Report

Mr. Cho reviewed the valuation report for the month ending July 31, 2017. The fund is valued at \$203,088,791.58 up \$5,592,660.83 from the previous month. The current asset allocation includes 60% in equities, 20% in fixed income, 3% in cash, 8% in alternative investments, and 9% in real estate. The total fund was up 1.86% for the month and up 8.68% year to date.

Mr. Cho reviewed the second quarter performance report. He discussed the investment perspectives, and then he discussed the total fund performance. The fund is valued at \$197,686,059. The current asset allocation includes 43.9% in equity, 20% in fixed income, 5.9% in alternative investments, 9.1% in real estate and 3.6% in cash. The total fund was up 6.62% year to date.

Chairman Grodi questioned the redemption period for Mesirow. Mr. Cho stated Mesirow releases 95% and will hold 5% in cash per their contract. Chairman Grodi questioned if that was standard. Mr. Cho stated yes, very standard.

Trustee McCarthy questioned if there were any reasons for the underperformance of Seizert Sm/Mid. Mr. Cho stated that there have been some portfolio changes, however they have reviewed the changes and found no issues.

Mr. Cho recommended terminating Wisdomtree and investing \$2.5 million of the proceeds with Cambriar and the balance with Renaissance.

Motion by Trustee Neely to accept Mr. Cho's recommendation to terminate Wisdomtree and invest \$2.5 million of the proceeds with Cambriar and the balance with Renaissance. Supported by Trustee Turner. Motion carried. Trustee Morgan voted no.

12. Old Business

1. Request for Proposal Investment Consultant

Trustee McCarthy made a motion to retain Graystone and review in one year. Supported by Vice Chairman Jondro.

Trustee McCarthy stated that she is impressed with new management, and impressed with their approach. She feels they deserve this.

Vice Chairman Jondro stated that he took another look at the 5 year performances. He ranked each company by performance from 1 to 13. Morgan Stanley managed 3 out of the top 5 companies. AndCo managed 2 out of the top 5 companies.

Trustee Morgan stated there are pros and cons for both Morgan Stanley and AndCo. Morgan Stanley is improving. He likes the idea of waiting a year.

Trustee Turner stated there has been a lot of underperformance in the past and does not want to put a ton of weight on the past year's performance. He voiced his concerns that no recommendation was made on a replacement for a manager after 2 underperforming quarters.

Trustee Koras stated that Morgan Stanley has stepped up over this past year, but that it was also around the time the board started the RFP process.

Trustee Bellaire stated that she has been back and forth also. She went over the review completed in 2014 and historically, Morgan Stanley has not lost as much during market downturns.

Chairman Grodi stated if AndCo was given a year and the board was not happy, they have a 100% money back guarantee.

Trustee McCarthy stated she has some reservations with AndCo.

Trustee Neely stated AndCo is completely independent and Graystone only sells Morgan Stanley products.

Vice Chairman Jondro questioned what to expect regarding transition fees if the board did choose to change investment consultants.

Mr. Michaud stated there would be changes to the manager portfolio. There would be costs involved to transition, however you would not make changes if there would not be a net positive.

Chairman Grodi contacted Trustee Lievens via telephone.
